JOURNAL OF BACTERIOLOGY

The *Journal of Bacteriology* is an official publication of the American Society for Microbiology. The *Journal* is devoted to the advancement and dissemination of fundamental knowledge concerning bacteria and other microorganisms.

The *Journal* is published monthly and the twelve numbers are divided into two volumes (January–June and July–December). The subscription price is \$20.00 per year, including *Bacteriological Reviews* (\$20.75 in Canada, \$22.00 elsewhere). Single copies, when available, \$2.00 in the United States, \$2.25 elsewhere. Members of the American Society for Microbiology may receive the *Journal* as part of their dues. All subscriptions should be renewed promptly with the Publishers or their Agents, since a supply of back issues cannot be guaranteed. Renewals and new subscriptions begin with the first volume of the year when subscription is received. A pro-rata adjustment is made in the invoice if any issue is out of print.

INSTRUCTIONS TO AUTHORS

CORRESPONDENCE. Submit manuscripts in duplicate (original and one carbon) to the *Journal of Bacteriology*, Department of Bacteriology, University of Wisconsin, Madison 6, Wisconsin. Send material by first class mail in flat form—not folded or rolled. The *Journal* cannot assume responsibility for manuscripts.

GENERAL POLICY. Any manuscript submitted must be a report of unpublished original research, which is not being considered for publication elsewhere. A manuscript accepted and published by the *Journal* must not be published again in any form without the consent of the Publisher and Editor.

Each manuscript will be reviewed by one or more members of the Editorial Board. Anonymity of referees is preserved in order that their criticisms may be frank and objective. The chief purpose of review is to

help authors avoid mistakes in their papers and to publish work that is a credit to themselves and the *Journal*.

A page charge, as well as charges for corrections on proofs in excess of 5% of the manuscript, will be assessed against authors after the manuscript is printed.

Authors submitting manuscripts from overseas are advised to appoint someone in the United States of America to correct proofs.

FORM OF MANUSCRIPT. Manuscripts (text, references, tables, legends, footnotes) must be typewritten in double or triple space, with wide margins, and on paper (8½ x 11 inches) suitable for ink corrections. Proofread manuscripts carefully before they are submitted.

PAPERS. Following a brief and concise introduction, a paper should be divided

into the following parts, in the order indicated: Materials and Methods; Results; Discussion; Acknowledgments; Literature Cited; Abstract (to follow title and byline).

NOTES. Manuscripts must be less than five hundred words and present the results of original research accompanied by adequate supporting data. Contributors should observe the bibliographical procedure adopted for notes in current issues of the *Journal*.

Authors should consult the *Style Manual for Biological Journals* for further details concerning the accepted form. The *Journal* reserves the privilege of editing manuscripts to make them conform with the adopted style, or of returning them to authors for revision.

NOMENCLATURE OF MICROORGANISMS. Binomial Latin names of microorganisms must be used in accordance with the International Rules of Nomenclature. Binomials should be underlined once in the type-written copy. A specific name must not be used without an accompanying capitalized

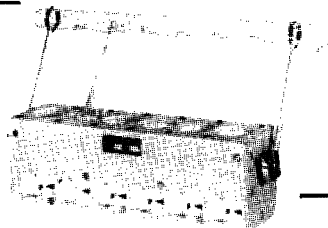
generic name. The generic name for each species should be written in full where it first occurs in the text and again in the abstract. Where the generic name appears frequently in the text it may be abbreviated by using the initial letter of the name. The nomenclature for bacteria presented in *Bergey's Manual of Determinative Bacteriology*, 7th Ed. (1957) is used. Where an author challenges this nomenclature his own judgment will be followed, but the name in *Bergey's Manual* should follow in parentheses the first time the name is used in the text. When new bacterial names are proposed in manuscripts, an international authority on nomenclature will be consulted for an opinion. Manuscripts containing new scientific names for protozoa and higher fungi will not be accepted by the *Journal*. Scientific epithets or trivial names should not be underlined in the manuscript. Strain numbers will not be accepted in the title of a paper.

REPRINTS. Reprints of articles will be furnished contributors when ordered in advance. A table showing cost of reprints and an order slip will be sent with the proof.
